

# Willamette Valley Stamp Exhibition: March 17-18, 2018

**in conjunction with Greater Eugene Stamp Society and Salem Stamp Society**

March 17, 10:00 to 4:00, at St. Jude's Catholic Church, 43rd and Willamette, Eugene

March 18: 10:00 to 4:00, at Red Lion Hotel, 3301 Market St., Salem

## Prospectus

**1. Eligibility.** This exhibition is open to all exhibitors. Entries must be the property of the exhibitor. Entries that have won a Gold (or Large Gold) award at a WSP show are not eligible.

**2. Classifications.** Section A (Adult), Section B (Youth), and C (non-competitive). Exhibits may be shown on only one day if the exhibitor wishes, but those exhibits will be non-competitive.

**3. Exhibit sizes.** Exhibits will be mounted in 16-page frames. Exhibits may be 1/2 frame (8 pages), or 1, 2, 3, or 4 frames. Youth exhibits may be 1/2 or 1 frame except by special arrangement.

**4. Entries.** An exhibitor may enter one or two exhibits. Each exhibit entry must include (1) the Entry Form, (2) the title page **and/or** a one- or two-page synopsis, and (3) the required fee. Entries should be mailed to George Struble, 210 18th Ste. NE, Salem, OR 97301. Closing date for entries is February 18, 2018.

**5. Fees.** Entry fee for Section A and C exhibits is \$5.00 for the first frame or half frame, and \$1.00 for each additional frame. The fee for Section B (youth) is \$1.00. Checks should be made payable to Salem Stamp Society.

**6. Judging.** Two regionally accredited judges will judge the exhibits. They may withhold an award if, in their opinion, no exhibit warrants it. Judges' decisions are final.

**7. Awards.** The list of available awards will be posted on the websites [greater Eugenestampclub.weebly.com](http://greater Eugenestampclub.weebly.com) and [salemstampsociety.org](http://salemstampsociety.org) as arrangements for awards are made. An awards ceremony will be held at St. Jude's Church in Eugene at 3:30 p.m. on March 17, and another at the Red Lion Hotel in Salem at 10:30 a.m.

**8. Delivery of exhibits.** Exhibits may be delivered to the St. Jude Church in Eugene between 8:00 and 9:00 on Saturday, March 17, or to George Struble in Salem before March 17; Eugene exhibitors may deliver their exhibits to Clarin Lewis or Mike Luttio. They may also be mailed to George Struble, Salem Stamp Society, P.O. Box 202, Salem, OR 97308, to arrive by March 14, 2018. Exhibits may be dismounted and picked up by the exhibitor or an agent at the Red Lion Hotel at 3:30 pm. on March 18. They can also be mailed back on March 19. If an exhibit is to be mailed back, mailing costs must be submitted with the exhibit Entry Form.

**9. Liability and Security.** All reasonable security precautions will be taken to safeguard all exhibits. The exhibitor agrees that Willamette Valley Stamp Show, Greater Eugene Stamp Society, Salem Stamp Society, St. Jude's Church, and the Red Lion Hotel assume no responsibility for damage or loss of exhibit materials. Exhibitors are expected to provide their own insurance.
